Refer below, we had a mixed bag result today – earlier in the morning we had issues delivering parcels to the Flemington Buildings and were outright turned away at the first building by a Police Officer at the second building we were given assistance and ultimately able to deliver all parcels for the Flemington buildings per below.

All the parcels relating to the 4 affected address in my catchment have been delivered to one point the Community Centre at 25 Mt Alexandra Rd, the driver was advised by the police that all in bound product is coordinated through the Community Centre.

North Melbourne proved to be more difficult as s 47 outlines below. The community centre there seemed to not really know what to do and we really had concerns about the security of the articles if we just left them as they were accessible and not secure.

Is it possible to contact Greg Murphy to see if we can get a better and more secure process to deliver at North Melbourne and ideally a contact for tomorrow?

We do want to deliver but not become villains because we delivered and the articles have disappeared.

The PDO & Ops Manager s 47 E(c) attended the Canning St (Nth Melb) high rise towers at approx. 11:45am, with them they had 3 days of large parcels (Colby) that were held at the PDC, 60 scannable SP (NMDC) 3 days of mail in addition to 70+ Express Post from Senator Hanson One Nation party.

On arrival Trent & the PDO went to the command post as directed where they met with Acting Senior Sergeant s 47F he advised he was not aware or had any communication regarding mail delivery or a process to follow. He tried contacting someone from DHS but after 15 mins

with no success, he referred Trent to the Nth Melb Community Centre across the road to speak to someone from DHS.

When Trent arrived at the community Centre, a volunteer at the gate who's role was to sign in and register volunteers directed Trent to **s 47F** from Vic Health Services. **s 47F** was also unaware of any mail deliveries or who to refer Trent to. She said that she was willing to take the mail and hold onto it, but could not say who would be responsible for the care and delivery and if the mail would be in a secure location. The community centre was full of volunteers and people coming and going, so I advised Trent not to leave the mail and return it to the facility until further notice. My concern being the risk of unsecured premises and the significant number of volunteers and potential for theft or lost mail.
